TUESDAY MORNINGS WERE A FAVORITE WITH HEALTHY SMOOTHIES PREPARED BY OUR CHEF.

OUR 4,000 VOLUNTEERS WHO ARE AN INTEGRAL PART OF OUR MISSION BECAME VIRTUAL VOLUNTEERS FROM THE SAFETY AND SECURITY OF THEIR HOMES PARTICIPATING IN READING TO THE CHILDREN, CRAFT ACTIVITIES OR COOL-A-THONS. THEY CONTINUED WITH THEIR MANY CORRESPONDENCES TO THE FAMILIES, FUNDRAISED AND CONTINUED TO BE OUR PARTNERS IN REIMAGINING OUR MISSION AND HELPING TO DELIVER OUR MISSION DURING A TIME OF CRISIS.

IMPORTANTLY, OUR DEDICATED VOLUNTEERS MEET AND GREAT OUR FAMILIES WITH CARE AND COMPASSION. THEY CAN BE FOUND WORKING AT OUR FRONT DESKS, HOUSEWARMING IN OUR KITCHENS, VOLUNTEER COOKING, LANDSCAPING, DOING MAINTENANCE WORK, VOLUNTEERING FOR EVENTS, CRAFTS AND GAMES AND VOLUNTEERING DAILY IN OUR KIDZONE LEARNING CENTER.
