WE WERE STAFFED WITH A KNOWLEDGEABLE AND HEALTHY TEAM AND WITH A STRATEGY THAT PROVIDED THE SAFEST POSSIBLE ENVIRONMENT FOR FAMILIES TO RETURN TO LIVING COMMUNALLY. WE WERE EXTREMELY CAREFUL WITH OUR DECISION MAKING AND CONTINUED TO FOLLOW THE LEAD OF OUR PRIMARY HEALTHCARE PARTNERS.

ALL RONALD MCDONALD HOUSES ACROSS THE WORLD HAD A STRATEGIC 5-PHASED REOPENING OF THEIR MISSION AND PROGRAMS. THESE PHASES EMBRACED THE STRATEGIES OF MODIFICATION, RENEWAL, MOMENTUM, STRONGER AND MISSION FORWARD.
